ACADEMIC ATTIRE AND DRESS CODE POLICIES:

Dale Junior High is a uniform school in order to promote school safety, school pride, and academic success.

It is expected that all students maintain a neat and orderly appearance while on campus. All students will comply with the following academic uniform attire and dress code. It is the responsibility of the student and the parent/guardian that the student adhere to the dress code. ***Administration reserves the right to modify or adjust the dress code as necessary.***

The following rules apply:

<ul style="list-style-type: none"> Students must wear a Dale school uniform polo shirt or Black, Red, or White unaltered polo shirt. Students can wear a Dale spirit shirts Mondays through Fridays. Students can wear an appropriate college themed shirt only on Thursdays. Students may wear one appropriately sized shirt underneath their uniform shirt, but it may not be larger than the uniform shirt. Students may not tie up their shirt by any means. Clothing must cover the midsection. Clothing must fit. Oversized shirts are not permitted. Shirts may not be longer than the fingertips in length with hands down to the side. All shirts/tops must have sleeves. 	<ul style="list-style-type: none"> Shorts and skirts must not be deemed too tight and must be mid-thigh length or longer. Pants/shorts/skirts must have no holes above the mid-thigh/ fingertips with hands down to the side. Clothing must fit. No sagging – pants must fit at the waist and crotch. NO SAGGING PANTS Boy's shorts may be no longer than just below the knee. High cuffed pants and high socks touching shorts are not permitted. Tights and bike shorts are not permitted. Skirts or shorts in appropriate length can be worn over them. PE clothes are not allowed to be worn during the school day or home from school. Pajamas are not permitted unless it is a spirit day. Sweats with more than two pockets are not permitted (Including Pro-Club shorts and sweats) 	<ul style="list-style-type: none"> Sweatshirts promoting feeder elementary schools, high schools, or colleges are acceptable to wear Monday-Friday. Dale sweatshirts are available for purchase in the Main Office. All top wear, sweaters, jackets, and long sleeve outerwear MAY NOT have inappropriate logos. Oversized sweatshirts and jackets cannot be over/under uniform shirts. Hoods must be down unless it's raining. 	<ul style="list-style-type: none"> Socks must NOT have inappropriate prints. Moccasins and slippers are not allowed (including Crocs). All shoes must have an enclosed toe and cover going all the way around the heel. Jewelry deemed unsafe may not be worn: facial piercings, plugs and spikes, hoop earrings; ear piercings no larger than a nickel are permissible. Sunglasses may not be worn. Belt buckles with initials or inappropriate graphics or language, wallet chains, spiked bracelets, collars, excessive metal on belts are not allowed. Hats, beanies, caps, sweatshirt hoods, bandanas, hairnets, scarves (unless required for religious reasons), headbands, or any other head coverings may not be worn on campus unless it is a Dale sanctioned hat. No gang related attire

**** Students may be asked to wear a loaner shirt or pants if School Administration deems the student is out of uniform.**

- Free Dress Days: Students will be invited to participate in ASB spirit weeks or free dress days. The following dress code policies still apply:
 - No straps can be exposed– Front or Back.
 - No cleavage can be exposed.
 - Pants/shorts/skirts must have no holes above the mid-thigh.
 - No clothes deemed too tight or too baggy.
 - Tights are not permitted.

Physical Education (PE) Dress Code

Requirements:

- Students are expected to wear a PE uniform (Shirt and Shorts)
- Students may purchase Dale's PE Uniform shirt or wear a plain grey t-shirt
- Students may purchase Dale's PE Uniform shorts or wear black shorts or sweats of any color with no pockets
- Students are expected to wear athletic footwear or rubber soled shoes
- Students who do not dress out are still expected (and will be given the opportunity) to participate in their Physical Education (PE) class and may do so in their school attire with no penalty to their grade.

In addition, the following items are **not** permitted on campus or at any school-sponsored event:

Dress, grooming or accessories which:

- Are unsafe, dangerous, or a health hazard
- Display offensive or obscene symbols, signs, slogans or words, degrading any cultural, religious or ethnic values.
- Contain language or symbols oriented toward sex, drugs, alcohol, tobacco, violence or weapons.
- Displays or contains, gang, tagger, crew and/or clique symbols, colors, slogans, signs.
- Hair designs, style or color that cause a disruption.

Academic Attire and Dress Code Violations:

- All academic attire and dress code violations will be documented on Aeries.
- Parents will be called and informed of Dress Code violation and will be asked to bring in proper uniform attire.
- Student may be asked to wear a loaner shirt or pants.
- Student will receive a detention for each Dress Code infraction

The academic attire and dress code policies will be enforced.

ACADEMIC HONESTY AND CHEATING POLICY

At Dale Junior High School, we value academic integrity and honesty; therefore, we enforce a strict academic honesty and cheating policy.

The following rules apply per district school board policy:

- **Cheating** by copying from others, providing work for others, allowing others to copy, tampering with teacher materials, having or using notes, formulas, or other information in a programmable calculator or other programmable electronic device is not permitted. Students who violate this rule will receive a failing grade on the assignment. Second offenses will result in the above discipline and a referral.
- **Plagiarism** by copying or using another person's work and submitting it as your own or acting as a provider of a paper or papers for others is not allowed. Students who violate this rule will receive a failing grade on the assignment, a "U" in citizenship. Second offenses will result in the above discipline and a referral.

ASSISTANCE FOR STUDENTS

Dale Junior High Staff prides itself on working together collaboratively to support your child in all areas. If you have any concerns and/or questions about your child's progress, please take into consideration the following suggested options to request support and/or ask questions:

1. Contact your child's teacher via phone or email to discuss concerns and/or ask questions.
2. Contact your child's teacher for an in-person conference to discuss concerns and/or ask questions.
3. Contact your child's counselor to request a meeting with all of your child's teachers (Parent-Teacher Conference).
4. Contact Dale's FACES (Family and Community Engagement Specialist).
5. Contact school administration.
6. If your child continues to need additional support in the general education setting, contact your child's counselor or administrator to fill out a "Request for Assistance" form. The request for assistance will be sent and reviewed by our Education Monitoring Team (EMT).

ATTENDANCE POLICIES:

ABSENCES FROM SCHOOL

Regular attendance is vital to a student's success in school. A student who is absent loses direct instruction that cannot be made up even though written work may be completed.

The only excused absences are those resulting from: illness, medical/dental appointments, or death in the immediate family. ALL other absences are considered unexcused.

When a student is absent, parents are required to call the attendance office at 714-220-4209 on the day of the absence before 9:30 AM.

If the absence is not verified by telephone, the student is to bring a note, signed by a parent, which includes the date(s) of the absence, reason for the absence, student's name, and grade. Absences will be considered unexcused if they have not been cleared within 24 hours. Unexcused absences will result in disciplinary actions.

TARDY POLICY

Students are expected to be on time to school and to each class. Tardiness will be excused only in the event of illness, medical/dental appointments. Excused tardies must be verified by the parent in person, or with a note. Oversleeping, missing the bus, etc., are not excused tardies. Students who arrive at school after 8:00 AM must sign in at the attendance office. Staff will conduct random Tardy Sweeps. Students found in violation will receive detention.

1st Tardy: Teacher Conversation

2nd Tardy: 2nd Warning

3rd Tardy: Call home and teacher consequence

4th Tardy: Call home and teacher consequence

5th Tardy: Referral to Administration

6+ Tardies: Attendance/administrative monitoring, interventions, and loss of privileges.

(Tardies will reset to 0 at the new semester).

**** Interventions include but are not limited to lunch detention, after school intervention, or loss of privileges.**

TRUANCY

According to the Education Code of the State of California, any pupil who is absent from school without a valid excuse more than three days in one school year, is truant and shall be reported to the site administration.

Students who are regularly truant will need to have a SART meeting with a parent and Assistant Principal. The following are considered trancies:

- Being absent from school without the knowledge and consent of the parent.
- Being absent from school without a valid excuse.
- Leaving the school grounds during the day without permission.
- Staying out of class without permission.

Period trancies will be addressed with progressive disciplinary actions by school administrators. This may include detention, parent conference, and/or a parent shadow day.

STUDENT PICK UP/CONTACT

If you need to contact your student during school hours, you may leave a message in the office at 714-220-4210.

- **If you need to pick up your student or contact them for any reason during the school day, it is encouraged to call ahead of time to allow enough time for student pick up.** Students will only be called out of class during the first 5 minutes in order to maximize classroom instruction and minimize classroom interruptions. If a request is not made in advance, parents/guardians may be asked to wait until the end of the period to contact/communicate with their student.
- Students must be picked up from school/leave no later than 3:00 PM unless they are participating in a school sponsored activity.
- **Lunch time at Dale is between the hours of 11:30 and 1:00pm. Students may be difficult to locate during lunch due to the volume of students. Please make arrangements and call the office before 11:30 if your student has an appointment during those hours.**
- Please make arrangements regarding when and where pick-up after school will take place.
- Be sure to let your parents know if you are staying after school for any reason. It is the student's responsibility to contact their guardian/parent.
- Students attending after-school events (e.g. Homework Club, After-School Intervention, and Anaheim Achieves) must report by 2:30pm.

LATE START:

- Late Start is every Thursday morning. On Late Start Days, school starts at 8:55 AM and ends at 2:25 PM.
- There will be NO Late Starts on the following Thursdays: 8/7, 12/18, 1/29, 5/21.

STUDENT PICK UP:

To minimize classroom disruptions, parents should call the attendance office at least one hour ahead of time or drop off a note to the attendance office, before picking up a child during the school day. Any parent that wants to call their child out of class, must preplan by communicating with the attendance office. Please call the attendance office 714-220-4209 to preplan a student pick up.

BEHAVIOR EXPECTATIONS:

The following expectations of behavior are designed to provide Dale Junior High School students with a safe, secure, and orderly educational environment. All guidelines apply during the time students are on campus, walking to and from school, and during any extra-curricular activity including, but not limited to: sports, field trips, night performances, and dances. (Education Code 48900.s)

BICYCLES/SCOOTERS/SKATEBOARDS/E-BIKES

Students are welcome to ride a bicycle to and from school if the following expectations are followed:

- According to the law, all students are expected to wear bicycle helmets to and from school.
- Students must stay on the designated bike paths. They must not ride bikes on school grounds. It is mandatory to walk a bike/scooter/skateboard/e-bike on and off campus.
- Bikes/scooters/skateboards/e-bikes must be put inside the bicycle racks and locked up. Sharing a lock is not permitted.
- Bicycle racks are off limits except when parking and picking up
- Trading/selling parts is not permitted. DJHS will not investigate if this behavior occurs.
- Students may not ride skateboards on school grounds. Skateboards must be locked up and not stored in classrooms. Skateboards with inappropriate markings or stickers may be confiscated.

BIRTHDAYS/HOLIDAYS:

- Please do not bring flowers, balloons or treats of any kind for students. These items are a distraction on campus and in the classroom. Birthday/Holiday items will not be allowed on campus. All items will be held in the main office and students can pick up the items after school.
- If you would like to acknowledge your child's birthday on our marquee for a day, with 1 week notice and \$20.00 we will display your birthday greeting for one week; call 714-220-4201 to make arrangements.
- Another option is to give your child a Birthday Shout Out during video announcements for

\$1.00. All money is contributed to the school site.

CAMPUS CLEANLINESS

We are very proud of our new facilities. The school campus is our shared environment. Our school's reputation in the neighborhood and with visitors is largely determined by our campus appearance. **All students are expected to help keep the campus clean.** While eating lunch, students must stay within the lunch areas and deposit all trash in the proper place.

CELL PHONE/ELECTRONIC DEVICE POLICY

In adherence with California State Law and School Board Policy, cell phones and other personal electronic devices must be turned off and in backpacks between 7:25-2:25 pm.

Dale JHS assumes no responsibility for the safety or security of these items. Dale personnel will NOT investigate the theft of these items. The Anaheim Union High School District will NOT reimburse for any lost or stolen electronic devices even if they are confiscated. Electronic devices are restricted by the Education Code set forth by the State Department of Education.

If a student uses a cell phone or personal electronic device anywhere on campus, without permission, the following rules apply:

- The device will be confiscated from the student.
- The cell phone will be returned **only** to the **parent/guardian** of the student.

Confiscated electronic devices will be labeled with the student's name and kept in the Main Office until the parent takes possession.

Any confiscated items that are not picked up will be donated at the end of the school year.

CLOSED CAMPUS

Dale Junior High School is a closed campus, and **students may not leave the campus, even if the school day has not started. Students may not leave campus before any school sponsored activity.**

Students may only leave campus if they are signed out by a parent or an adult designated by a parent or legal guardian. **ALL** visitors must check in to the main office to be on school grounds during school hours. **A photo ID is needed to sign out students.**

CHROMEBOOKS

Students are responsible for Chromebooks issued to them. Lost, stolen, or damaged Chromebooks must be paid for by the student or parent. Parents are highly encouraged to purchase the District Chromebook insurance at the beginning of the Academic School year. Chromebook insurance must be purchased each school year.

EVENT CONTRACT

When attending a Dale Junior High School dance or event, a permission slip is required. The student will agree to act in accordance with the rules and regulations of the school. If the rules and regulations are broken during the dance, the student will be asked to leave without a refund and appropriate consequences will be assigned by administration.

Dances:

Dance tickets may be purchased the week of the dance, and/or the day of the dance. To make the dance appropriate for school and comfortable for everyone, the following dance rules and regulations will be in effect:

- Dale students may not invite outside guests to the dance.
- No moshing, slam dancing, "freak" dancing, or battle dancing will be permitted.
- No kissing, holding hands, hugging, or body contact at all.
- No fighting or arguing.
- Uniform policy will be enforced.
- Backpacks can't be picked up until the student leaves.

Dances start at 2:30 PM and end at 4:00 PM. Parents should pick up their children immediately afterwards. The main office phones will not be available.

Sports:

To attend any sporting activities, students must acquire a wristband from school administration the day of the event. **School administration reserves the right to deny anyone admittance.**

Students are not permitted to leave campus before any school sponsored activity. Students may lose dance/sports privileges due to progressive disciplinary actions.

DRUGS, ALCOHOL AND TOBACCO

In keeping with the policies of the Anaheim Union High School District as set forth by the Board of Trustees, Dale Junior High School will enforce the rules and laws regarding drugs, alcohol, and tobacco.

Substances include: Alcohol, tobacco, marijuana, amphetamine, prescription medication, over-the-counter medication (Advil, Tylenol, cold medicine, etc.), vape juice/pens, other controlled substances, and drug paraphernalia (including e-cig chargers).

The following rules apply:

- Bringing illegal substances to school or holding them for someone may result in a 5-day suspension, a referral to the Pathways to Success Program, transfer to another school, and/or arrest.
- Giving or selling illegal substances, in any amount, to someone else may result in expulsion from the school, district, and/or arrest.
- Being under the influence of an illegal substance while at school or a school sponsored event may result in a 5-day suspension, Pathways to Success Program, transfer to another school, and/or arrest.
- Any found devices or substances must be disposed in trash or turned in to an administrator immediately.

Students who are under a doctor's care and require prescription medication throughout the day must give all medicine, as well as a physician's note, to the school Health Technician. The school Health Technician will secure and dispense all medication per doctor's orders. Update doctor's notes with the Health Office after doctor's appointments.

FAMILIARITY AND PUBLIC DISPLAY OF AFFECTION

Students must refrain from familiar contact at school, such as kissing, hugging, etc. Parents will be notified in cases where students violate this rule.

GRAFFITI:

Do not bring permanent markers of any kind to school. Students may not have graffiti writing in or on their folders, backpack, clothing, and/or body. Graffiti that is confiscated will be turned in to the Anaheim Police Department.

Backpacks with writing or graffiti will be confiscated for a parent to pick up.

GUM:

Gum is **not allowed** on school grounds. Progressive discipline will be followed for repeat offenders.

HARASSMENT/BULLYING/CYBER-BULLYING

It is the policy of this school that all students be treated with respect and feel comfortable attending school.

- Any harassment that substantially interferes with a student's school performance or creates an intimidating, hostile, or offensive learning environment will not be tolerated.
- The harassment of others based upon sexual, religious, racial, or other themes will not be tolerated. Verbal, physical or cyber-bullying, calling others a name which puts them down, using words which insult another person, touching others in an unacceptable manner, and making comments of a sexual nature are considered harassment.
- In addition, participating in harassment or cyber-bullying through the use of technology (telephone, text messaging, online text, or social networking sites) will not be tolerated, and will result in referral to an administrator and progressive discipline will be implemented.
- If, at any time, you feel uncomfortable in dealing with other students or adults on campus, you are responsible to report concerns to a parent, teacher or administrator, who will assist you with your concerns.
- Bullying/Cyber-Bullying and Harassment of any kind is unwelcome. All unwanted behaviors that make a student feel uncomfortable can include: *Derogatory comments, physical aggression, extortion and social exclusion.*
- Bullying is also a behavior directed at a person because of his or her race, gender, religion or sexual orientation.
- Bullying is a negative pattern of behavior repeated over time.
- Report all incidents of Bullying/Cyber-Bullying and Harassment to a staff member.
- Be sure to tell the person bullying or harassing you to STOP! and Unfriend/Unfollow/Block if cyberbullying is taking place.

HOMEWORK REQUESTS

Students are given the opportunity to make up school work missed because of excused absences. The amount of credit awarded will be determined by the teacher.

If a student is absent for fewer than three days, the student should keep up with assignments by calling an "Assignment Buddy" or checking eKadence **It is the responsibility of the student to get make up work from the teachers upon returning to school.**

*** All assignments are available online via the eKadence platform**

ID CARDS

Students MUST carry their student identification cards with them at all times.

Student ID Cards will be available to students within the first month of school. A student ID card authorizes a student to be on campus and **every** student must have their student ID card in their possession at all times while on campus. Students using a lunch account must also use their ID card. **A replacement ID card is available for \$5.00.** Students are expected to carry their ID card daily.

INJURY/ILLNESS

If any injury or illness occurs after a student arrives at school, he/she is to report to the teacher and then to the health office. **Please make sure the most up to date contact information is in Aeries. In an emergency, we cannot contact parents without correct phone numbers in Aeries.**

INTRAMURAL SPORTS:

Students are encouraged to participate in extracurricular activities.

Quarter 1: Boys Basketball, Girls Soccer, and Cross Country

Quarter 2: Boys Flag Football, Girls Volleyball, Boys Tennis

Quarter 3: Boys Volleyball, Girls Flag Football, and Girls Tennis

Quarter 4: Boys Soccer, Girls Basketball, and Track

LIBRARY

Any student must have current Student ID Card to check out books from the library or use a computer. Students may check out a maximum of three library books for a two-week period. After two weeks, they have the option of renewing or returning books. A late fee of \$.10 per day, per item will be charged for books returned after the two-week period. Students are encouraged to take care of books and technology materials and return them in a timely manner. Any lost or damaged books **HAVE** to be replaced. Any damaged technology items, including laptops, desktops, or mobile devices have to be replaced or paid to be repaired.

LOCKERS

Students will be assigned a locker for P.E. Clothes/valuables are to be secured in this locker during the P.E. class. It is the student's responsibility to ensure all personal items and valuables are safely locked and **NOT LEFT IN THEIR BACKPACKS DURING THE PE PERIOD unattended.** The school is **not** responsible for lost/stolen items. Sharing lockers and locks is not permitted. Replacement locks can be purchased in the office.

LOST AND FOUND

Each year a large number of items are turned into the office. Lost items are placed into a lost and found container. Students or family members may come to the office to ask for lost items. At the end of each quarter, unclaimed items are donated to a charitable organization.

LUNCH POLICY

Students are welcome to bring their own breakfast or lunch items from home. Breakfast and lunch are also provided for all students for free.

Door dash and other delivery services to students are not permitted at any time.

MEDICATION

Medication should be taken at home with parent supervision whenever possible. Prescriptive and non-prescriptive medication may be taken at school only under supervision of school personnel. Parents must deliver medication to the health office in the original container.

Under California Law, a medication form which includes dosage instructions must be completed by the parent and the physician before medication can be administered at school. These forms are available in the health office.

MISSING SUPPLIES/HOMEWORK BROUGHT IN BY PARENTS

It is the student's responsibility to remember all books, lunches, PE clothes, assignments, etc. However, if the parent brings items for their student, the parent must sign the item in at the main office. There will be no interruption of classroom instruction to deliver forgotten items.

PARENT ENGAGEMENT

Several parent organizations and committees, such as PTSA, Coffee Chats, EL Advisory Committee, and School Site Council, provide valuable volunteer time, financial support, and advice for the overall improvement of our school site. School effectiveness is positively impacted by frequent parent participation. Meetings are publicized regularly on our school website and Aeries Communications.

Class visitation is a courtesy extended to parents upon requests. Class visits must be approved by an Assistant Principal in advance. To ensure the safety of our students, all visitors are required to check in through the main office before proceeding to a classroom.

Teachers communicate with parents about student progress in a variety of ways. These include calls, notes, emails, and progress reports. In addition, parents are encouraged to inform school personnel

about significant changes in the home environment that may affect the student's school performance.

PERSONAL PROPERTY

Students are discouraged from bringing to school any personal property which is not directly related to the instructional program. Further, students should not bring personal items such as watches, jewelry, perfume/cologne or other items which are fragile or expensive. **The school will not be responsible for any student's personal property which is lost, stolen, or damaged.**

Technology devices such as cell phones, gaming devices, iPads, laser pointers, or recording devices of any kind are not appropriate for school and should not be brought to school. Failure to adhere to this policy will result in confiscation of the items and a referral will be issued.

PROGRESSIVE DISCIPLINE POLICY

In keeping with the goal of maintaining an academically focused school in which every student has an opportunity to learn, Dale Junior High School has developed a Progressive Discipline Policy which is consistent with the Anaheim Union High School District's Policy of Progressive Discipline.

Our goal is to put in place consequences which successfully modify negative behavior patterns. Therefore, the following consequences are in place for rule and expectation violations:

- Referral to Administration
- Administrative Behavior Monitoring Sheet
- Lunch Detention
- Teacher Detention
- Teacher Period Suspension

- AUHSD Discipline Contract
- Off Campus Suspension
- Referral to the EMT Process
- Transfer/Expulsion

OFF CAMPUS SUSPENSION

- Students are not allowed on campus or at school-sponsored events.
- Students have access to all assignments via eKadence

Students who have been administratively transferred to another school site are not allowed on campus unless accompanied by parent/guardian. Failure to comply will lead to a trespassing notification.

SELLING ITEMS AT SCHOOL

The selling of candy, food, and/or any kind of item or property by any student or group not authorized by administration is **not** permitted on school grounds or at any school-sponsored event.

STUDENT AGENDA PLANNER

We provide all students with an agenda planner during the first week of school. The student agenda planner must be brought to school each day. If lost or damaged, the cost to replace the student agenda planner is **\$5.00**. Replacement agenda planners can be purchased in the Main Office.

TEXTBOOKS

Students are responsible for all textbooks issued to them by the school district. Lost, stolen, or damaged textbooks must be paid for.

TRAFFIC ON CAMPUS

If you are picking up and dropping off your students please be sure to follow these directions:

There are 2 lanes in the parking lot. The far right lane is the Bus Lane. Do not park in the bus lane for any reason. If you are picking up your student from the street, please park by the curb in the street and have your child cross the parking lot **ONLY** in the crosswalk.

WEAPONS, CHEMICALS, AND DANGEROUS OBJECTS

It is our intent to make Dale Junior High School a safe place for everyone. Our policies are those of the Anaheim Union High School District as set forth by the Board of Trustees. We will enforce the rules and laws regarding weapons and dangerous items at school.

Chemicals include items that are flammable or potentially allergenic such as: nail polish, nail polish remover, body spray, perfume, cologne, hairspray, etc.

Weapons include: Real or fake knives of any shape or size, real or fake guns, and any other dangerous objects (lasers, poppers, pepper spray, tasers, fireworks, stink bombs, etc.).

Bringing or possessing weapons (real or "look-alike") or dangerous objects at school may result in disciplinary consequences, suspension, transfer to another school, arrest and possible expulsion from the district.
